

The Kansai Economic Federation (Kankeiren) was established in October 1946 as a comprehensive economic organization made up of individual economic organizations, businesses, and other entities. Its original mission was to represent the Kansai business community's views on economic revitalization, thereby helping to rebuild Japan's economy, which had been ravaged by the Second World War.

Since then, the Kankeiren has contributed greatly to the economic development not only of the Kansai region, but all of Japan, by engaging in a wide range of activities: for instance, promoting such major Kansai-based projects as establishing Kansai International Airport and Kansai Science City; promoting international exchange and interaction primarily in the Asia-Pacific region; and formulating policy proposals to strengthen industrial infrastructures, and encourage the self-reliance and development of local communities. We celebrated our 70th anniversary in 2016, with the number of our members growing to approximately 1,300.

Since 2020 the Covid-19 pandemic has severely impacted the entire world, taking a heavy toll on economies and societies in Japan and elsewhere. With turbulent political and economic conditions both here and abroad, the ongoing advance of digital transformation, and a range of other developments, companies currently face a dizzying array of changes.

The pandemic has exposed various issues Japan needs to address as a country, the slow pace of digitalization and vulnerabilities from overconcentration in the Tokyo area among them. The situation, however, can be seen as an opportunity to finally tackle a host of long-standing challenges, to move forward with decentralization, to promote work style reforms, to raise productivity. The pandemic then should be viewed as an opportunity to take firm steps toward putting the Kansai economy back on the track of robust growth with a view to its strategic development over the medium to long term.

The Kankeiren created a long-term vision in December 2020, our first in twelve years, Kansai Vision 2030. The vision, whose basic concept is "Kansai; a pioneer region, with the spirit of the first penguin," defines what we want Kansai to be, what Kansai should be in 2030: "An economy that is open and creates original values," "A stage that attracts people," and "Front line of new social models." It also sets out the direction of Kankeiren's activities for achieving this vision in the form of "7 Arrows."

The next ten years to 2030 will undoubtedly be a key transition period for transforming and renewing Japan's socioeconomic systems, and it is also poised to be a period of opportunity for Kansai, which will be in the global spotlight with World Expo 2025 in Osaka, Kansai. It is time for Kansai to be a pioneer, to boldly take on challenges in "the spirit of the first penguin" in order to transform difficulty into opportunity while also carefully considering the accelerating changes being caused by the pandemic.

-The long-term vision of Kankeiren ~ "Kansai Vision 2030"

What is "Kansai Vision 2030"?

- -The long-term vision defines what we want Kansai to be, what Kansai should be, moving toward 2030, and sets out the direction of Kankeiren's activities to achieve it.
- -The vision's basic concept, which runs through the entirety, is "Kansai; a pioneer region, with the spirit of the first penguin." What we want Kansai to be, what Kansai should be in 2030 is "An economy that is open and creates original values." "A stage that attracts people," and "Front line of new social models." To this end, the Kankeiren will let fly "7 Arrows" from two standpoints, "Look West" and "One Kansai."

The first penguin is the one that breaks away to plunge headfirst into uncharted water, where predators might be lurking, in search of food. In turn, we call those who take the lead in pioneering into new territory are known as first penguins.



Major Activities

Major Activities Globalism/Asia and Exchanges International Committee, Urban Creation, Tourism and Culture Committee

We aim to act as a bridge, creating business opportunities between companies in Asian countries and those in Kansai, by working to introduce businesses from both sides to each other. For example, we provide the Asia Business Creation Platform (ABC Platform) for increasing business exchange between Kansai and seven Asian countries*, as well as opportunities for

exchanges with government agencies and business people in China and other countries. We also build a network through human resources development programs, including the Kankeiren ASEAN Management Seminar, send business delegations to foreign countries, receive important foreign dignitaries, and hold seminars on international affairs, the investment environment, and other topics. *Indonesia, Malaysia, Myanmar, the Philippines, Singapore, Thailand, and Vietnam

Moreover, looking ahead to World Expo 2025 in Osaka, Kansai and subsequently attracting an integrated resort to the region, we provide support for initiatives to revive and increase inbound travel to Japan and Kansai through the Kansai Tourism Bureau, a regional destination management/marketing organization established jointly by government and business in Kansai. Further, we are involved in urban development projects like Yumeshima, Umekita Phase 2, and Shin-Osaka to enhance the appeal of urban areas after the expo and also in preserving and transmitting the historical and cultural resources situated throughout Kansai.

Decentralization/Regional Administration Decentralization and Regional Administration Committee

In order to further regional autonomy and promote the development of each region by making full use of their own strengths and individuality, we consider it necessary to achieve decentralization and implement the so-called "Doshu-sei" regional government system. Toward this end, we formulate recommendations and promote them to the government and ruling party, and work to encourage public debate and discussion.

The committee proposed and brought into being the Union of Kansai Governments, the only regional administrative body in Japan that spans prefectures. The union and the Kankeiren collaborate in requests to the central government while promoting industry, tourism, sports, disaster prevention, and women's advancement, encouraging wide-area cooperation in the Kansai region.

Advancement of Diverse Human Resources

Labor Policy Committee, Diversity and Inclusion Sub-Committee

For Kansai to become "a stage that attracts people," we are helping companies develop employment and working environments that enable diverse human resources to fully demonstrate their abilities. This includes making recommendations to companies and government bodies on attracting top-level talent, a source of competitiveness, in order to raise corporate productivity and promote the sustained development of local communities.

In addition, to make Kansai a leader in diversity and inclusion, we encourage companies to adopt the D&I Guidelines we have created and fully integrate them into their workplace practices. Along with these initiatives, we provide timely, appropriate information on amendments to employment and labor law and other related topics.



DX

Digital Transformation Special Committee

In order for digital transformation (DX) to make tangible, broad-based progress in Kansai amid the rapid development of the digital environment in both public and private spheres, we have created the Kansai DX Strategy 2025 (provisional title), which defines future ideals, identifies challenges to be addressed to realize them, and presents measures being taken in the region, and are carrying out initiatives by which DX is utilized to promote industry and regional development.

Infrastructure

National Land and Regional Infrastructure Committee

We are working to establish a multi-hub structure for the country that contributes to national resilience, by consolidating ideas and necessary recommendations and promoting them to the government. Regarding transportation and logistical infrastructure, we are addressing four main areas: (1) Early full opening of the Hokuriku Shinkansen and Linear Chuo Shinkansen lines, and prompt improvement of the regional railways in Kansai; (2) Rapid completion of the missing links to the ring road network, which is lagging behind the Tokyo and Chubu areas; (3) Optimum utilization of three of the airports in Kansai working together - Kansai, Itami, and Kobe; and (4) Revitalization of harbors and other international logistics.

Industrial Innovation

Science Technology and Industrial Development Committee, Venture Ecosystem Committee

With a view to creating a cluster of next-generation growth industries in Kansai, promoting innovation, and utilizing it at the World Expo 2025 in Osaka, Kansai, we are working to promote and make good use of areas where Kansai has strength, including health and medical care, the aircraft sector, energy and the environment, and IoT/AI and robotics.

We are also involved in various efforts to build a startup ecosystem and solve social issues through collaboration between business, government, and academia in Kansai's urban areas and to make Keihanna Science City a major center for open innovation.

Corporate Systems and the Power of Private Sector Corporate Legislation Committee

We conduct research on mechanisms for effectively harnessing the power of the private sector, based on the principle of shared benefit and with a focus on the social aspects of corporations, in order to facilitate the full integration of the multistakeholder model into corporate management. Based also on the changes taking place in the socioeconomic environment, we consider and propose corporate systems like quarterly reporting that help raise medium- to long-term corporate value. In addition, we provide information through various seminars on trends in corporate systems and other related topics (the Antimonopoly Act, corporate accounting standards, the Companies Act, etc.).

Physical and Mental Health

Sports Promotion Committee

We have created the Kansai Sports Promotion Vision in FY2018 to make Kansai people healthier and the region livelier through sports. We have also established Kansai Sports Promotion Councils as a platform for industry, academia, government and athletes in Kansai to discuss ways of promoting sports in the region. Based on this vision, we are working with various stakeholders, including municipalities, economic organizations, sports associations, and universities, in a range of areas to promote the playing, watching, and support of sports-by supporting top athletes, promoting lifelong sports, attracting sporting events, and promoting the sports industry.

Environment and Energy

Global Environment and Energy Committee

We make recommendations for the stable supply of inexpensive electricity, the backbone of economic growth, and for the promotion of energy policy premised on safety, energy security, economic efficiency, and the environment ("3E+S") and environmental policy fully compatible with the economy. We are also involved in activities to increase understanding of environment and energy policy among young people.

Economic and Fiscal Policy

Economic and Fiscal Policy Committee

We compile recommendations on the tax code and fiscal policy and promote them to the government and ruling party with the aim of supporting economic growth while restoring fiscal health. This involves, for example, suggesting revisions to the corporate tax code in support of corporate activities and performing research on the social security system in light of the changes taking place in Japan's society and economy. In addition, to make Osaka, Kansai a characteristic hub for international finance, we participate in the Global Financial City Osaka Promotion Committee (administered by the Osaka prefectural and municipal governments) and help the committee formulate strategy.

Kansai Economic and Management Summit

2025

A longstanding annual summit at which Kansai-based corporate managers meet to discuss national and regional issues and corporate management. The summit has been held every February since 1963, and since the 41st seminar in 2003 it has been co-sponsored by the Kansai Association of Corporate Executives and Kansai Economic Federation. In fiscal 2020, the summit was held online for the first time because of the Covid-19 pandemic and related factors.

West Japan Economic Council (Nishikeikyo)

The council consists of the six economic federations of western Japan (Kansai, Hokuriku, Chubu, Chugoku, Shikoku and Kyushu). It establishes positions for western Japan as a bloc and makes requests of the government and ruling party. Established in 1965. A resolution is adopted at the general assembly held every autumn.
